\* Selection criteria: general cancer registries with prevalence data available up to Jan 1, 2013 and at least 10 years of registration at the index date (9 years for the national registries of Cyprus and Belgium). The index date was Jan 1, 2013 for all registries except Slovakia (Jan 1, 2011), Croatia, Saarland, Ferrara, Sassari, Varese, Canary Islands, and Tarragona (Jan 1, 2012). These exceptions allowed to increase the population coverage in Europe (four more countries) and in Germany, Italy, and Spain.
